## LOSS

The Gainesville cycling community has lost three of its most prominent members.



Two, GCC members **Margaret Raynal** and **Doug Hill**, died while riding with a Gliders group on December 26<sup>th</sup> heading to St Augustine to participate in a cross-state ride. A driver apparently fell asleep at the wheel and ran off the road as he came up behind the group. Four other riders, three of them club members, were injured in the crash. An overflow assemblage attended Doug's funeral on December 30<sup>th</sup>, and



cyclists from all over the state gathered for a memorial service for Margaret and Doug on January 11<sup>th</sup>. There are additional articles inside this newsletter.



**Kermit Sigmon** passed away on January 14<sup>th</sup> of liver cancer. Kermit was one of the most important activists in the formation of the bicycling facilities that we have in Gainesville today. He lead the move away from the narrow, bumpy separated paths with the dangerous intersections at roadways and driveways to the type of facility we now have on roads such as north 39<sup>th</sup> Ave and NW 43<sup>rd</sup> St. His experienced counsel was always looked forward to on his frequent visits to the Bicycle/Pedestrian

Advisory Board. We all owe a debt of gratitude to Kermit for helping make Gainesville the most bicycle friendly city in the South.

We (GCC) have received many telephone calls, and letters expressing anguish in hearing about GCC's loss of two of our members. There were calls from Alabama, Georgia, Minnesota, and from various parts of Florida.

Statements such from the (Tampa Bay Freewheeler's) "Please accept our condolences with regard to the losses to the Gainesville Cycling community." The (Montgomery Bicycle Club) "I was in Florida on vacation over the holidays and saw the TV news report about the accident which killed Doug Hill and Margaret Raynal. I want to express our club's deepest sympathies for the families of these riders and for the club members who shared the roads with these individuals and the other cyclists who were injured in the accident." Minnesota "This is horrible." "We have posted information regarding the tragedy on our home page, and we would like to be kept informed. "

There were also many letters and messages via the internet expressing the same sorrow. Most just wanted to share their feelings, others communicate ideas, and information. Others just wanted to do something to make the wrong of this tragedy leave a meaning of right. To date they are still coming in. May it continue, never letting us forget what happened to two wonderful people and four others on December 26th of 1996 in the State of Florida.

When I returned to work that following Monday, a dozen or more of my coworkers stopped to tell me how sorry they were about this tragedy (these were non cyclists). They are in the medical field dealing on an everyday experience of life, death, and tragedies. They sought me out as if this tragedy had involved one of my family members. I will tell you I was very moved by their spontaneous compassion for "our cycling community". They were people who probably had not ridden a bicycle for two decades or more, yet they understood the vulnerability of all bicycle riders. They knew sometimes the law abiding cyclist depend many times on the motorist to take heed, to just simply share the road. They expressed that cyclist as the motorist have every right to travel the roads of Florida. They did not understand why Mr. Lassiter did not do the same.

I know many are concerned with the on going investigation. As of this date 1-19-97 it is still on going. Mr. Lassiter could still face "Vehicular Homicide" and this without a positive drug test. "Could." Most have expressed that without the charge of "Vehicular homicide" the Green Cove Springs States Attorney will be sending a message to all motorists that we "are fair game."

Gainesville is a cycling community and we need now, more than ever, to work toward a better understanding between all of us, cyclists and non-cyclists. Whether we like it or not we sometimes have to share the road with people who think driving a motorized vehicle is a right. That having a license to drive is a right, and that we the cyclists have no rights and should be riding on the sidewalk.

We make the Laws and Statues, and only we can change them. Lt. Lupper was following

guidelines set by you and I. And as many others I, too, assumed that if a fatality occurs that drug testing was mandatory. Maybe some statutes need to be changed. Maybe we need to become more involved in local issues, attending a few public DOT meetings. We should be fighting for every highway in the State to have either shoulders or a bike path. We should attend more public meetings, voicing our needs.

# Club Rides

The purpose of the Gainesville Cycling Club is to expedite the process of getting people together to do group rides. We do this in several ways.

The most obvious way is to advertise a schedule of rides with set starting times and meeting places. Some of these rides are otherwise totally informal (all weekend A Rides, for example), and others have designated ride leaders (most Gliders rides).

Another method we use is to have designated riding groups. This enables a member to identify those riders that are most compatible with their riding style, and to have a group of riding friends that they can call when there is an opportunity to ride when no ride is advertised.

We publish a roster of club members with information about how each likes to ride (speed and distance). With this, members can find others to get together with and do group rides.

While we encourage members who will be doing group rides to advertise them in the newsletter, on the RideLine, and/or on the gcc-fla email list, there is no requirement to do so. Group rides of members of the GCC are considered "club rides" when the ride is initiated by a club member and involves, for the most part, other club members. A ride initiated by a non-member, in particular another group (for example Team Florida), is generally not a GCC club ride.

If this is beginning to sound a bit on the "legal" side, it is because the only time that this distinction is important is when our insurance company has to get involved. Club members are covered by our insurance policy while on club rides, but not while riding alone, commuting, or riding with a non-club group. If being covered by the insurance is important to you, be aware of the makeup of the group ride you are on, and how it has been advertised. To eliminate complications, a group may elect to have guests sign an insurance waiver each time they ride with the group. Contact Roger Pierce to obtain them.



## RIDING GROUPS

**A Riders.** (no Group Captain). Will usually choose a middle or long distance ride. The route may change without notice at any time. The group will frequently split into two or more groups. These rides can be very fast, and do not necessarily make rest stops. On the weekends, these rides are usually joined by riders from the Revolution Sports Society racing team, and frequently by Team Florida and other miscellaneous racers.

**Gliders.** Barry Gibbons, 372-1145. Rides with ride leaders in the upper B range (17-19 mph average). Meeting times and places vary; see the schedule on this page. Rides will normally be around 50 miles in length.

**Sliders.** Bill Boyette, 338-2945. Rides in the lower B range (15-16 mph average) on Saturdays. Meeting times and places are sent to group members by email about a week before the ride. Call Bill or email to Wdbest@aol.com to join the group.

**Roadies.** Sam Sullivan 371-8218. Rides in the lower B range (15-16 mph average) on Sundays. Call the group captain if you are interested in a ride. Rides will normally be around 40 miles in length.

**Hunters Crossing Pedalers.** Linda McMahon, 331-4089. Meets at the GRU facility on NW 43<sup>rd</sup> St just north of NW 53<sup>rd</sup> Ave, most Saturdays for a slower paced ride. 
